### SEWER SCHEDULE OF CHARGES - ORDINANCE NO. 10-2019

Sewer charges shall be made by the City and billed to the owners of real property serviced by the sanitary sewer system at a sanitary sewerage rental or charge of four hundred and fifty (\$450) dollars per year for each Equivalent Dwelling Unit (EDU). The number of EDU's in residential properties shall be determined in different instances as follows:

<u>TYPE OF STRUCTURE</u>	<u>EDU</u>
--------------------------	------------

a. Residential:

Single Family Dwelling	1
Apartment, each living unit	1
Condominium, each living unit	1

b. Non-residential:

Non-residential users shall be charged at a minimum annual rate of one (1) EDU, plus additional gallonage above the minimum allowance of 120,000 gallons. The rate at which sewerage service for non-residential users will be furnished for usage in excess of the above gallon allowance is \$2.50 per 1,000 gallons.

*Approximately 48% or \$216.00 of your current charges is the Atlantic County Utilities Authority Treatment charge.*

### WATER SCHEDULE OF CHARGES - ORDINANCE NO. 10-2019

6"	\$1,380.00	720,000

Residential single-family dwellings, apartment living units and condominium living units shall be charged at the rate of individual one-inch (1") meters where water service is supplied through a common main and common internal water system.

### RATES FOR WATER CONSUMED

The following shall be the rate at which water will be furnished for usage in excess of the above gallon allowances: \$2.50 per 1,000 gallons
